Mike made a motion to approve the minutes of the December 23, final meeting of the year and Chad seconded the motion and the motion carried.

Mike made a motion to pay the following claims and Chad seconded the motion and the motion carried.

Election of President for 2015--- Mike made a motion to appoint Kenneth Reinbrecht as President and Chad seconded the motion and the motion carried.

Mike made a motion to designate the Princeton Daily Clarion as the paper for publications and Chad seconded the motion and the motion carried.

Mike made a motion that the 1st Monday of the month at 6:00p.m.would be the monthly meetings and Chad seconded the motion and the motion carried. IF Monday is a holiday, the meeting would be held on Tuesday.

There was a request for a possibility of a street light at 1100 S. and West St., Bryon would contact Vectren and report back at the next meeting.

In the Fire Dept.: Eric reported a total of 25 runs for the month of December. A total of 269 for the 2014 year.

He stated the fire helmets were outdated. Quotes for replacing 32 helmets were as follows:

Mid- America Fire and Safety ------\$13,248.00 (32x \$414.00) Fire Store ------\$13,970.88 (32X \$436.59)

Chad made a motion to purchase the helmets from Mid- America Fire & Safety at a cost of \$13,248.00 and Mike seconded the motion and the motion carried.

Eric asked to spend some money on building two or three props. Chad made a motion to allow up to \$1000 to make props for training and Mike seconded the motion and the motion carried.

Eric asked to implement a \$300 clothing allowance per firefighter, per year, for firefighters that would be on call and stay at the station. Everyone would have a uniform which would be a pair of pants, boots and shirt that represented the department and be presentable. Chad made a motion to approve the \$300.00 clothing allowance for the firefighters staying at the station, on call and Mike seconded the motion and the motion carried.

Eric was needing lights repaired at the station and council told him to contact Oing Electric.

The department has a 1989 FMC Ford Pumper in need of both pumps, has an electrical problem and a new scene light is needed. An estimate would be gotten from Gerry's in Mt. Vernon.

A training session for reporting runs will be held in Terra Haute on January 24th. Someone from the department will attend.

In the Street Dept.: nothing

In the Water Dept.: Membership to the Indiana Alliance of Rural Water is due at a cost of \$176.00. Mike made a motion to pay the annual membership at a cost of \$176.00 and Chad seconded the motion and the motion carried.

There was some discussion at that meeting about garages and if they would be demolished too. Who makes the call on if it is stays or goes? Debbie Bennett would be contacted on who would make that call if the building would stay or be demolished.

Joe had some information on a collection agency that has been used to collection past due money owed for utilities and cleanup, etc.

Herb Bethe's trailer is gone and the Miller property is looking better.
